

**ROYAL T MODEL LIMITED WARRANTY**

Snake River Trailer, Company hereby warrants to the original purchaser that each Snake River Trailer, Co Re: Royal T Model trailer when operated by the original purchaser under normal conditions in the Continental United States or Canada will be free from defects in materials and workmanship for 2 years following the original purchase. This warranty is subject to all of the requirements, exclusions, and limitations stated herein which will be strictly applied. Any use whatsoever of the trailer for rental or commercial purposes shall invalidate this Limited Warranty.

**YOU MUST SEND US A SIGNED COPY OF THIS WARRANTY**

In order to validate this Limited Warranty, the original copy of this form, signed by the dealer and the purchaser, must be postmarked and mailed to, Snake River Trailer, Co P.O. Box 879, Caldwell, ID 83606 no later than ten (10) days following the purchase of your Snake River Trailer, Co - Re: Royal T Model. IF THIS SIGNED WARRANTY IS NOT POSTMARKED BY THE TENTH DAY AFTER PURCHASE OF THE TRAILER, ALL EXPRESS WARRANTIES CONTAINED IN THIS LIMITED WARRANTY SHALL BECOME NULL AND VOID.

**TWO YEAR LIMITED WARRANTY**

Subject to the requirements, exclusions and limitations set forth herein, the manufacture warrants to the original purchaser for a period of two years from the date of purchase, that the structure of the Snake River Trailer, Co - Re: Royal T Model is free of defects in the materials and workmanship by Snake River Trailer, Co. This limited warranty is good only when the unit is subjected to normal use by the original retail purchaser in a non commercial manner. The structure is that part of the trailer that includes the main frame, which consists of bottom rails, cross members, side posts and exterior walls, roof rails and bows, and the subframe, excluding the floorboards and running gear.

**ONE YEAR LIMITED WARRANTY**

Subject to the requirements, exclusions and limitations set forth herein, all other components of your Snake River Trailer, Co - Re: Royal T Model are warranted to the original purchaser for a period of one (1) year from date of purchase, against any defect in the materials and workmanship by Snake River Trailer, Co when the trailer is subjected to normal, non commercial use.

**EXCLUSION OF COMPONENTS WARRANTED BY OTHER MANUFACTURERS**

Tires, axles, brake components, springs and suspension components, couplers, jacks, castors, mats, batteries, windows, and doors purchased and installed by Snake River Trailer, Co are warranted by their manufacturers and are excluded from this Limited Warranty.

**NORMAL USE, NO REPAIRS OR ALTERATIONS**

This Limited Warranty is limited to defects in the original warranted components which arise after normal use and does not apply if the trailer has been subjected to abuse, misuse or negligence, or it has been damaged in an accident, has been overloaded or has been repaired or altered without the prior written consent of Snake River Trailer, Co. Normal wear items, including but not limited to doors, fiberglass roof, struts, lights, bearings, brakes, brake linings, tires and batteries, will not be replaced because of wear. Damage caused by the environment is not a material or workmanship defect, it is controlled by climate, environment and customer's style of use. Vendor supplied parts and options will be covered separately, and not by this Limited Warranty.

**TRANSPORTATION COSTS EXCLUDED**

Transportation of any trailer to and/or from your dealer or any approved repair facility shall be the responsibility of the trailer owner. Snake River Trailer, Co shall not be liable for any such transportation or for those costs.

**PRIOR WRITTEN CONSENT REQUIRED AND RETURN OF DEFECTIVE PARTS REQUIRED**

No reimbursements will be made to any dealer or owner for repairs made without the prior written consent of Snake River Trailer, Co. Any defective part(s) must be sent by prepaid freight to Snake River Trailer, Co in order to qualify for replacement or reimbursement under this Limited Warranty.

**OTHER PRODUCTS EXCLUDED**

This Limited Warranty applies exclusively to Snake River Trailer, Co - Re: Royal T Model trailers manufactured by Snake River Trailer, Co. Any other products manufactured by Snake River Trailer, Co are specifically excluded from this warranty. Authorized repairs do not extend the term of the Limited Warranty. You are required to send in all warranty forms for the various components in the trailer.

**LIMITATIONS**

THE SOLE RESPONSIBILITY OF Snake River Trailer, Co UNDER THIS LIMITED WARRANTY SHALL BE TO REPAIR AND REPLACE PARTS AT THE Snake River Trailer, Co FACTORY. REPAIRS AT AN ALTERNATE LOCATION SHALL NOT BE COVERED UNLESS THERE IS PRIOR NOTICE TO THE MANUFACTURER AND A WRITTEN AUTHORIZATION IS OBTAINED FROM Snake River Trailer, Co. ALL OTHER OBLIGATIONS OR LIABILITIES, INCLUDING INCIDENTAL OR CONSEQUENTIAL DAMAGES OR CONTINGENT LIABILITIES ARISING OUT OF THE FAILURE OF ANY PARTS TO OPERATE PROPERLY, ARE HEREBY EXCLUDED, INCLUDING BUT NOT LIMITED TO ANY DAMAGES RESULTING FROM LOSS OF USE, INCONVENIENCE, LOSS OF TIME, COMMERCIAL LOSS OR ANY OTHER TYPE OF DAMAGE, GENERAL OR SPECIFIC, FORESEEN OR UNFORESEEN, UNLESS APPLICABLE STATE LAW PROVIDES OTHERWISE. ALL OTHER WARRANTIES, EITHER EXPRESS OR IMPLIED, ARE HEREBY EXCLUDED. THE WARRANTY OF FITNESS FOR A PARTICULAR PURPOSE IS EXCLUDED.

**DISCLAIMERS**

The scope of this warranty is expressly limited to only items actually constructed by Snake River Trailer, Co therefore makes no warranty with respect to component parts constructed or assembled by other manufacturers, including, but not limited to, Dexter, Carlisle, etc. Such component parts may be warranted by their respective manufacturers, and copies of such warranties are included with the trailer. As the manufacturer of the trailer which you purchased, Snake River Trailer, Co does not know the purpose you have in mind for your tow vehicle and trailer, nor does Snake River Trailer, Co know the Gross Vehicle Weight Rating ("GVRW") of your tow vehicle. Therefore, Snake River Trailer, Co makes no warranties or representations, express or implied as to the performance of your tow vehicle with the trailer or whether the match-up of your tow vehicle and trailer exceeds the GVRW as specified by your tow vehicle's manufacturer. Specifically, there is no express or implied warranty of merchantability or of fitness for the particular match of your vehicle to any particular trailer.

The undersigned dealer by signing this manufacturer's Limited Warranty, certifies that the dealer has explained to the purchaser and the purchaser has been informed of the limited warranty and of the claim procedures and will perform all responsibilities of the dealer under this Limited Warranty.

IF THIS WARRANTY IS NOT SIGNED, POSTMARKED AND MAILED TO Snake River Trailer, Co BY THE TENTH (10<sup>th</sup>) DAY AFTER THE PURCHASE OF THE TRAILER, ALL EXPRESS WARRANTIES SHALL BE NULL AND VOID.

Required procedures for filing a claim under this Limited Warranty are listed on the bottom of this form.

By signing this manufacturer's Limited Warranty, THE PURCHASER ACKNOWLEDGES THAT HE OR SHE HAS READ THE ABOVE LIMITED WARRANTY AND AGREES THAT SHOULD ANY WARRANTY CLAIMS BE MADE BY PURCHASER, THE PURCHASER WILL FOLLOW THE PROCEDURES AS SET FORTH ON THIS FORM.

**DEALER RESPONSIBILITIES**

Selling Dealer is responsible for "dealer prep" which includes checking all cosmetic features and repairing all minor problems without charge to the purchaser or the manufacturer. Your dealer is also responsible for submitting to the manufacturer any claim you wish to make under the terms of this Limited Warranty.

**REQUIRED WARRANTY CLAIM PROCEDURE**

- In order to validate this Limited Warranty, the original copy of this form, signed by the dealer and the purchaser, must be postmarked to Snake River Trailer, Co no later than ten (10) days following the purchase of the Snake River Trailer, Co - Re: Royal T Model. IF THIS SIGNED WARRANTY IS NOT POSTMARKED BY THE TENTH (10<sup>th</sup>) DAY AFTER PURCHASE OF THE TRAILER, ALL WARRANTIES OF ANY KIND, SHALL BE NULL AND VOID.
- Within five (5) days after discovery of a problem which is covered by warranty with your Snake River Trailer, Co - Re: Royal T Model, return your trailer for inspection to the Snake River Trailer, Co dealer where you purchased your trailer. If it is not possible to return to the selling dealer, call the Snake River Trailer, Co factory and they will provide you with the location of the nearest authorized dealer or repair facility. Dealers are responsible for fixing minor problems without charge to you or the factory.
- If your dealer cannot repair the problem free of charge and you want to file a claim under this Warranty, your local dealer must send to Snake River Trailer, Co by registered letter or fax a limited warranty claim form (eg. warranty request form), together with all required information, within ten (10) days of your discovery of defect.
- Snake River Trailer, Co will acknowledge such receipt of claim by registered letter to the dealer and to the claimant. Snake River Trailer, Co will respond as soon as possible, but not later than thirty (30) days after receipt of claim.
- Any defective part(s) must be sent prepaid freight to Snake River Trailer, Co in order to qualify the claimant for replacement of reimbursement under this Limited Warranty. ANY DEFECTIVE PARTS MUST BE RETURNED TO Snake River Trailer, Co WITHIN THIRTY (30) DAYS FROM DATE OF APPROVAL TO QUALIFY FOR REIMBURSEMENT.
- Snake River Trailer, Co will not reimburse any claimant for any adjustment or repair of your Snake River Trailer, Co - Re: Royal T Model trailer without prior written approval by Snake River Trailer, Co.
- Snake River Trailer, Co reserves the right to refuse payment of unreasonable costs for replacement or repair of defects in Snake River Trailer, Co - Re: Royal T Model trailers and may, at its discretion, establish a reasonable reimbursement for any authorized work performed under the terms of this Limited Warranty.

Snake River Trailer, Co MAKES NO OTHER EXPRESS OR IMPLIED WARRANTIES AND THERE ARE NO OTHER WARRANTIES, WHICH EXTEND BEYOND THE DESCRIPTION ON THE FACE OF THIS LIMITED WARRANTY.
